### **Incredibly Important Intellectual Oil Overlap**



Oil vaulted off the \$75.21 year-end print and gained 17.2% in January. After four consecutive weeks of gains, I've updated the outlook, and I'm noticing that it is still quite bullish. There's more.

It was vastly eye-opening to listen to Joe Rogan, and Jordan Peterson kick off their 4-hour tour de force podcast discussing energy and climate change. Why? Because hypocrisy and outright danger of the global green energy push are getting exposed to a MUCH larger audience than I ever imagined. Joe Rogan Experience sized audience, so we're talking tens of millions of people.

When you hear JBP echo the conversations that I've had with Doomberg, the synapses in your brain start firing, and you know you're on the right bloody track. (That's just a word Jordan uses a lot, and I want to bring it back.)

The street consensus and speculator consensus for oil are overwhelmingly

bullish to get the "group think" negative out of the way. Every shop on the street has a target of \$100 or more. This may or may not be a case where the obvious is correct. We'll soon find out but here's why I'm looking up, and then we'll connect the Rogan dots.

- The Houthi rebels appear happy to drone everything in sight.
- Russia's Ukraine incursion is causing nothing but a realization of geopolitical upside risk. Recall that there was no geopolitical risk to markets during the last Administration when gasoline was \$1.85 a gallon.
- Inventories are starting the year below five-year moving averages.
- OPEC's spare capacity decline is due to the same righteous underinvestment we're forcing on ourselves. It will become a bigger problem in its inability to contain oil prices.
- The IEA tells us that physical oil demand is more robust than expected. To pre-covid levels and beyond.
- An Obama-appointed judge just <u>nixed the offshore drilling leases</u> issued by the Biden Administration last year.
- Doomberg points out, in our <u>second of many more *Real Vision*</u> <u>conversations to come</u>, there are fewer DUC's in line for the oil industry to readily tap than ever before. Drilled But Uncompleted Wells data is making new lows since the advent of shale production, which will slow our ability to come up with oil when we need it.
- Exxon Mobil just reported the biggest profit since 2014. They printed a \$2.05 quarter versus \$1.93 estimates; their downstream petroleum product sales are up 12% year-over-year; both oil and

gas production beat estimates; they're going to achieve emissionreduction plans ahead of schedule, and they announced a \$10B share repurchase program after returning \$15B to holders in 2021. They are firing on all cylinders.

Exxon is looking to gap open higher, around \$76.75, and that's probably a good place and time to let out some length in the name or make a sacrificial XOP sale to the trading Gods. Brent crude has given up its \$90 handle this morning and could pull back a few dollars.



At this point in the energy trade, even I'm looking at my account and saying, "**Man, I'm glad TG got us into** oil in November 2020 (for the second long trade) and the oil & gas ETF XOP (for the second time) in early December 2021. So far, so good." But we're traders, and if we're high-fiving with one hand, we should be making sales with the other.

These are the times you should participate and look to replenish on dips and listen to Joe and Jordan connect a few dots that I've connected in this publication and on Real Vision with Doomberg many weeks/months ago.

Jordan Peterson: "That's the old saying, "When the aristocracy gets a cold, the working class dies of pneumonia." It's like okay, so fine, increase energy costs. Well, what happens? A bunch of poor people fall off the map, like a bunch of them. And the more you increase energy costs, the more that happens. And so if the price we have to pay to move toward a sustainable environment is increased energy costs – and it isn't, that's a policy decision, it doesn't have to be that way, the absolutely 100% inevitable consequence of that we are doing is that you sacrifice the poor."


